NOTICE IS HEREBY GIVEN that on Friday 16th August 2024 Rushcliffe Borough Council made and formally sealed the above Variation Order ("the Order") under its powers contained in Sections 35(1) and 35(3) and 35C of the Road Traffic Regulation Act 1984 and Regulation 25 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 (SI 1996/2489) and of all other enabling powers.

The Variation Order relates to amendment of the Principle off-street parking places Order (the Rushcliffe Borough Council (Civil Enforcement Off-street Parking Places) Order 2020) provided by the Council at the location listed in the Schedule of Parking Places as detailed below and is intended to come into operation on Monday 30<sup>th</sup> September 2024 (or as soon as possible thereafter).

The Notice of Proposal to make the Variation Order was published on site at each parking place, published on the Council's website and advertised in the Nottingham Post on 15th July 2024 inviting comments and objections. - 2. The following wording has been substituted in the schedule of parking places as detailed below and described hereto within: Bingham, Market Place, Plan ref: MPMDB8, Category D1, Column 7, amended to a permit parking provision between midnight and 10:00am on market days
